In the past year, CISSC case-managed over 400 students, achieving significant outcomes: 69% of students improved their Social Emotional Learning (SEL), 78% improved attendance, 81% improved their grades. Additionally, 94% achieved their college readiness goal and 79% achieved their career readiness goal.
